 In the process of negotiating the financial offer and signing the service contract. A1.2. Re-evaluation of the institutional educational offer in the field of Education Sciences.

 26 programs were submitted at the National Agency for Quality Assurance in Education and Research in order to initiate the external quality assessment procedure.

A1.3. Development of 8 new higher education programs (bachelor's and master's).

 3 bachelor's programs and 5 master's programs were identified and approved, to be developed. TOR were developed for the selection of individual consultants. A.1.4 Elaboration of the training program for pedagogical practice mentors and teaching staff training.

• Under implementation. The program was elaborated. 3 training sessions for teaching staff are planned between September 11-16, 2023.

A.2.2 Re-evaluation of university courses in Information Technologies

• The Terms of Reference for the selection of a national expert were developed and published. The aim of providing services for the modernization of 4 university courses in Information Technologies (2 courses for bachelor and 2 for master), will be included in the programs of the field of Education Sciences. The curricula and curricular supports for modernized courses will be developed.
